ORDINANCE 2013- *le*

AN ORDINANCE TO AMEND THE EMPLOYEES  
OF OCEAN CITY, MARYLAND PENSION PLAN AND  
TRUST AND THE OCEAN CITY, MARYLAND PUBLIC  
SAFETY EMPLOYEES PENSION PLAN AND TRUST

NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY MAYOR AND CITY COUNCIL OF OCEAN CITY, THAT THE EMPLOYEES OF OCEAN CITY, MARYLAND PENSION PLAN AND TRUST AND THE OCEAN CITY, MARYLAND PUBLIC SAFETY EMPLOYEES PENSION PLAN AND TRUST BE AMENDED BY REPEALING AND REENACTING WITH AMENDMENT SECTION 1.32 OF THE EMPLOYEES OF OCEAN CITY, MARYLAND PENSION PLAN AND TRUST AND SECTION 1.31 OF THE OCEAN CITY, MARYLAND PUBLIC SAFETY EMPLOYEES PENSION PLAN AND TRUST, AS FOLLOWS:

THE EMPLOYEES OF OCEAN CITY, MARYLAND PENSION PLAN AND TRUST

1.32. TRUSTEES means, collectively, the Trustee or the Trustees, and their successor or successors, who are designated herein or who are appointed pursuant to the terms of the Plan. The Trustees shall include, the Mayor, the Council President, three members of the community, who are appointed by the Mayor with the consent of the Council, and one individual who (1) is a Covered Employee, (2) has been elected by Plan Participants to serve as a Trustee, and (3) is affirmed by the Mayor and Council to serve as a Trustee (hereinafter referred to as "Participant Representative Trustee").


THE OCEAN CITY, MARYLAND PUBLIC SAFETY EMPLOYEES PENSION PLAN

1.31. TRUSTEES means, collectively, the Trustee or the Trustees, and their successor or successors, who are designated herein or who are appointed pursuant to the terms of the Plan. 
