OCPD Narcs Charge Pittsville Man with Distribution of Cocaine

On Saturday, December 20, 2008, at 8:40 P.M., the Ocean City Narcotics unit with the assistance of the Worcester County Criminal Enforcement Team concluded a one week CDS distribution investigation with the arrest of Kwamaine Dealon Fisher, 18, from Pittsville, MD.

On two separate occasions an undercover Ocean City narcotics detective was able to purchase powder cocaine from Fisher in Ocean City. Fisher was charged with two counts of distribution of powder cocaine, and two counts of possession of cocaine. A total of fourteen grams of cocaine and one hundred and sixteen dollars in U.S. currency was seized.

Fisher was seen by an Ocean City District Court Commissioner and held on \$25,000 bond. Fisher was later transferred to the Worcester County Jail.
