OCPD ARREST 11 AFTER NIGHTCLUB FIGHT

Shortly after 2:00 am on Saturday, July 26, 2008, Ocean City Police officers were on routine patrol in the area of 1701 Philadelphia Ave when a fight broke out inside the Paddock Nightclub. When officers arrived on the scene, they observed Paddock door staff escorting several people out of the facility and on to the public sidewalk. After exiting the nightclub, the fighting continued between the Paddock patrons.

As officers began making arrests for disorderly conduct and other violations, friends of the arrestees became involved in the incident by either interfering with arrests or refusing to leave the scene as ordered by officers.
