POLICE ARREST TEN DURING BAR CLOSING FIGHT

Shortly after 2:00 a.m. Saturday morning, Ocean City Police were called to Seacrets Night Club on 49th Street because of a large fight. When officers arrived on the scene, they observed several hundred people involved in an altercation in the parking lot.

More than 23 officers from Ocean City Police (including three OCPD police K-9 teams), Worcester County Sheriff's Office, and the Maryland State Police were needed to disperse the crowd. Officers were assisted by Seacrets security personnel.

During the incident, an Ocean City Police K-9 handler was assaulted and a K-9 dog bit one of the resistant and combative suspects. The following persons were arrested:
