PAROLE VIOLATOR LOCATED IN OCEAN CITY

On Friday, November 14, 2008, Ocean City Police Officers located a man wanted for parole violation from Harrisburg, Pennsylvania, for a 3rd Degree Murder Conviction. The subject was identified as Richard Michael Simmons, 41 years old, of Harrisburg, Pennsylvania.

OCPD police located Simmons after officers conducted a registration check of his vehicle. Police contacted the Pennsylvania Office of Parole and Probation and were surprised to learn that Simmons had been on the run since July 2008. OCPD Officers took Simmons into custody without incident.

Simmons was seen by an Ocean City District Court Commissioner and is being held at the Worcester County jail without bond, pending extradition back to Pennsylvania.
