OCPD NAB CANDY THEIF

On Friday, June 5, 2009, Ocean City Police officers responded to Candy Kitchen at 2:50 a.m. for a report of an alarm. While approaching the establishment, officers noticed two men that appeared to be arguing. As officers approached the men, later identified as Ian Lyons, 21, from Cork, Ireland and Darragh McCarthy, 22, from Ocean City, Lyons began to run from police.

At this time, McCarthy became very uncooperative with police officers and refused to obey police orders to stay off of the roadway. Ocean City police officers placed McCarthy under arrest for Obstructing and Hindering. In addition, Lyons was placed under arrest for Disorderly Conduct.

As officer searched Lyons, they noticed several bags of Candy Kitchen brand candy in his pockets. When asked where the candy came from, he told officers that he had purchased the candy two days prior. OCPD officers and Forensic Services members located additional boxes of candy in the parking lot of Candy Kitchen.

Lyons had approximately \$20.00 worth of Candy Kitchen candy in his pockets. In addition to his charges of Disorderly Conduct, he was charged with 2nd Degree Burglary and Theft.

He was seen by a District Court Commissioner and released after posting \$5,000 bond. McCarthy was charged with Obstructing and Hindering and was released on his own recognizance.
