### FOUR SALISBURY MEN ARRESTED FOR DRUGS

On Saturday, May 30, 2009, at approximately 9:00 p.m., an Ocean City Police officer was on uniformed bike patrol in the area of Worcester Street when he noticed a smell of burning Marijuana coming from a parked car. While approaching the vehicle, the officer observed four male occupants, later identified as: Jimyron Lamar Hurt, 01/30/90, Curtis Lamonte Mills, 07/30/90, George Wilber Stevens III, 04/20/91 and Damon Phillip Boston, 10/22/90, all of Salisbury, Maryland. In addition, the OCPD officer observed that the front passenger, Mills, had what appeared to be Marijuana in his lap.

Once the occupants of the vehicle recognized the uniform officer, they quickly locked the vehicle's doors and reached under the seats of the vehicle and into the waistband of their clothing. After numerous requests to exit the vehicle, the occupants of the car refused to comply with Ocean City Police officers. In order to make entry into the vehicle, one OCPD officer deployed his expandable baton, which gave access to the front driver's side window.

OCPD officers continued to instruct the occupants to exit the car, advising they were under arrest. Two of the passengers exited and attempted to flee the scene. The other two occupants exited the car and complied with the police and were taken into custody. The two persons who ran from the car were both apprehended a short distance from the scene by responding OCPD officers.

A search of the vehicle recovered several items of suspected controlled dangerous substances, including Marijuana and Cocaine.

- Curtis Lamonte Mills: Was charged with possession of Marijuana and Cocaine, possession of CDS paraphernalia and Resisting Arrest.
- Damon Phillip Boston: Was charged with possession of Marijuana
- Jimyron Lamar Hutt: Was charged with possession of Marijuana and Cocaine, possession of CDS paraphernalia and Resisting Arrest.
- George Wilber Stevens, 3<sup>rd</sup>: was charged with possession of Marijuana.

All the suspects were seen by an Ocean City District Court Commissioner. Hutt and Mills were each released after posting a \$5,000 bond. Boston and Stevens were released on recognizance.
