OCPD ARREST MAN WITH A GUN ON THE BOARDWALK

On Sunday, May 25, 2008 at about 10:40 P. M., Ocean City Police officers responded to 9th Street and the Boardwalk, in reference to a man threatening people with a gun.

Officers arrived in the area and met with several citizens who advised them that a male had been involved in an argument with a female acquaintance. The male was identified as James Edward Mansfield, 21 – years - old, of Hinesville, Georgia.

During the incident, Mansfield was confronted by several of the female's friends, during which, Mansfield produced a loaded .40 Caliber Glock handgun and pointed it at the group while on the public street.

The female called police from a cell phone and reported the incident as it was happening. OCPD officers immediately responded to the area. A broadcast for Mansfield was put out over the police radio system. Officer's spotted Mansfield attempting to flee the area at 7th Street and Baltimore Avenue.

Mansfield was apprehended by officers at 6th Street and Wilmington Lane. Mansfield had allegedly dropped the loaded .40 Caliber pistol while fleeing the area. Police recovered the gun shortly after Mansfield was arrested.

Mansfield has been charged with 1st Degree Assault, 2nd Degree Assault, Wear and Carry Handgun on a Person, and Reckless Endangerment.

Mansfield was seen by an Ocean City District Court Commissioner and released after posting a \$10,000 bond.
