OBSERVANT CITIZEN HELPS POLICE CATCH SUSPECTS WHO DAMAGED CARS

On June 20, 2009, at approximately 02:45 A.M., Ocean City Police responded to the 100 block of 13th Street, in reference to a citizen report of two males damaging parked cars.

The caller provided police with a very detailed description of the suspects and their direction of travel. Police were able to locate the suspects close to the scene of the vandalism. The suspects were both identified by a witness and subsequently arrested for the Malicious Destruction of four different vehicles. Police have identified the suspects as; Kyle Scott Hartzell, 23-years-old of Ocean City and Bruce James Richardson, 23-years-old of Wildwood, Michigan.

Both Richardson and Hartzell were seen by an Ocean City District Court Commissioner and released on their own recognizance.
