OCPD SEIZE CRACK COCAINE AND MARIJUANA FROM VISITING DRUG DEALERS

On March 20, 2009, members of the Ocean City Police Department's Narcotics Unit received information concerning two individuals who arrived in Ocean City from Baltimore, MD, with a quantity of drugs. The two individuals were identified and located at the Parrot Lagoon Apartments at 409 St. Louis Ave.

The Ocean City Police Department's Quick Response Team executed the Search and Seizure warrant at the apartment. Narcotics Unit Detectives recovered crack cocaine, approximately a quarter pound of Marijuana, packaging materials, and seized \$2,708.00 U.S. Currency.

The two following subjects were located inside of the apartment and charged with the following:

- Vicky L. Brown : 53-years-old from Baltimore, Maryland
 - Charges: Possession W Intent to Distribute CDS (Crack Cocaine) and Possession of CDS (2X) (Crack Cocaine/Marijuana)
- Antwan D. Brown: 26-years-old from Baltimore, Maryland
 - Charges: Possession W Intent to Distribute CDS (Marijuana) and Possession of CDS (Marijuana)

Both Antwan Brown and Vicky Brown were seen by an Ocean City District Court Commissioner. Both received a \$35,000 bond and were transferred to the Worcester County Jail.
