POTTSTOWN MAN ARRESTED FOR ASSAULTING HIS GIRLFRIEND

On August 22, 2009, at approximately 4:27A.M., Ocean City Police responded to the Seascape Motel, 1510 Baltimore Ave, Unit 210, in reference to an unknown disturbance.

Investigation at the scene revealed a man and woman staying in room #210 had been involved in a domestic argument prior to police arriving at the scene. Officers learned that earlier in the evening the victim and her male companion had been out at an area night club and became very intoxicated. Once back at the motel, the couple had an argument, during which the male assaulted the female victim. While at the scene officers noted the victim was complaining about neck pain. The victim was transported to Atlantic General Hospital. It was later determined the victim suffered a fracture in one of the vertebra in her neck as a result of the assault.

Based on the victims injuries police arrested Jeffery Robert Martin, 25 years-of-age, of Pottstown, Pennsylvania. Martin has been charged:

- First Degree Assault
- Second Degree Assault
- Reckless Endangerment

Martin was seen by an Ocean City District Court Commissioner and was held on \$200,000 bond. Martin was transferred to the Worcester County Jail.
