### **12 MONTH DRUG INVESTIGATION RESULTS IN 3 ARRESTS FOR OCPD**

The Ocean City Police Department recently concluded a 12 month drug investigation that resulted in the arrest of three individuals. The primary suspect of the investigation, Claiton Pacheco, 38-years old, of Ocean City, was being investigated by the OCPD Narcotics Unit for Distribution of Controlled Dangerous Substance (CDS).

The OCPD served a Search and Seizure warrant at Pacheco's residence located at #11 - 43<sup>rd</sup> Street. Once in the residence, police located Pacheco along with Paul Young, 27-years old, of Edgewater, Maryland and Ashleigh Ann Smith, 30-years old, of Ocean City.

Police recovered Crack Cocaine and numerous items of drug paraphernalia from the home. Pacheco was charged with seven counts of Distribution of CDS (Cocaine), eight counts of Possession of CDS (Cocaine) and one count of Possession of CDS (Crack Cocaine). Young and Smith were charged with Possession of CDS (Crack Cocaine) and Possession of Drug Paraphernalia. In addition, Smith had an outstanding warrant for her arrest from Anne Arundel County.

Pacheco, Smith and Young were all seen by an Ocean City District Court Commissioner. Pacheco was held on \$200,000 bond and Smith was held on a \$5000 bond. Young was released on his own recognizance. Pacheco and Smith were transferred to Worcester County Jail.
