OCPD Officer locates Rape Suspect during Traffic Stop

On March 6, 2009, at 2:30 P.M. Ocean City Police stopped a car for a traffic violation. During the stop OCPD PFC Michael Richardson identified the driver as Franklin Timothy Brinker, 19-years old of Selbyville, Delaware.

A computer check conducted by PFC Richardson revealed Brinker to be wanted by Baltimore County Police for a 2nd Degree Rape, Robbery, Theft, Assault and Malicious Destruction of Property.

Brinker was taken into custody without incident by OCPD.

Brinker was seen by an Ocean City District Court Commissioner and released after posting a \$100,000 bond.
