### OCPD MAKES DRUG ARREST AFTER MONTH LONG INVESTIGATION

On Monday, March 9, 2009, the Ocean City Police Departments Vice/Narcotics Unit concluded a one month long Controlled Dangerous Substance distribution investigation.

Police arrested three suspects identified as Donnell Lamar Taylor, 27-years old, Sara Elizabeth Morells, 19-years old and Patrice Shelton, 18-years old all of Ocean City, Maryland.

Taylor and Morells were both charged with possession with the intent to distribute Marijuana and possession of Marijuana. Shelton was charged with possession of Marijuana and possession of Hydrocodone.

Police seized approximately 182 grams of Marijuana, 4 Hydrocodone pills, and a 1999 Jeep Cherokee.

All of the suspects were seen by an Ocean City District Court Commission. Shelton was released on her own recognizance. Morells was released after posting a \$25,000 bond and Taylor was held on a \$25,000 bond and transferred to the Worcester County Jail.
