TWO MEN ARRESTED FOR ASSAULT

On July 16, 2009, at approximately 02:02 A.M., an Ocean City Police bike patrol officer observed a male later identified as: Jeffery Allen Lyles, Jr., 23-years-old, of Salisbury, Maryland assaulting another man on Jamestown Road. The OCPD bike officer arrested Lyles for 2nd Degree assault.

After the arrest of Lyles, numerous persons remained in the area of Jamestown Road and Coastal Highway. Additional officers responded to the area to disperse the group which had become increasingly larger and more defiant.

Police made one additional arrest for 2nd Degree assault of a police officer and failure to obey police. Officers and were able to eventually break up the crowd. The second person arrested was identified as; Darian Lamar Waters, 21-years-old, of Snow Hill, Maryland.

Both Waters and Lyles were seen by an Ocean City District Court Commissioner and released on their own recognizance.

Ocean City Police remind visitors that after last call (2 A.M.), patrons should leave the establishments property. Use designated drivers or public transportation. If you remain in the area and become disorderly or engage in illegal behavior, officers will arrest you.
