Employee Evaluations – Summative Evaluation Paints the Entire Picture

Although satisfactory evaluations are very important, they are only one aspect of each person's summative performance rating. Employee commendations, incidents, responsibility for equipment, amount of time worked, amount of time taken off, fulfilling work agreement, and last day worked are all considered by the review panel. Following through with what you told us you would do is critical and will affect your eligibility to return. Only after a full and complete assessment is completed will a final recommendation be made to the Captain regarding an employee's status for the next season.

Letters will be sent out by April 1 only to those employees receiving an A rating and who will be invited to return for the 2013 season.

If you need to know your status before this time, you can contact HQ after November 4, 2012.

A Note from Captain about the Marine Animal Rescue Program

If you trained this past summer on Monday, August 27, 2012, I need some information from you, and I need to give you some important information.

Although we had 45 people attend the training, Jennifer Dittmar, the MARP Stranding Coordinator, only had 8 paperwork packs with her. She sent the additional books and we attempted to distribute them at a Monday meeting, but only a very few people remembered to pick them up.

What I need from you: Did you get a packet from Jennifer that night?
Have you picked up a book from BP after that night?
Which of the below options are you planning to pursue?

There are two options that our personnel have. Both will provide OCBPSRA certification, so make sure you complete the requirements of the program you wish to participate in.

1. OCBPSRA MARP certification only (required for OCBPSRA Instructor Certification).
 - You must attend a full training (we held one back in Nov 2011, another one was held on Aug 27, and we have one scheduled for Saturday, November 3, 2012, in the OCBP training room at 6:00 PM)
 - You must complete the take-home test and submit to Jennifer Dittmar, MARP Stranding Coordinator
2. National Aquarium "official" MARP volunteer
 - You must attend a full training we held one back in Nov 2011, another one was held on Aug 27, and we have one scheduled for Saturday, November 3, 2012, in the OCBP training room at 6:00 PM)
 - You must complete the take-home test and submit to Jennifer Dittmar, MARP Stranding Coordinator
 - You must submit a volunteer application
 - You must attend update trainings when available
 - You must be available in the Baltimore, D.C., or Ocean City area
