Handicapped Parking Policy in Ocean City

The Town of Ocean City extends **free** parking privilege to persons from any state who either have a handicapped registration tag or are displaying a state issued handicapped tag from the vehicles rear view mirror. You may park free of charge at any parking spot (paid or not) or in a designated handicapped parking spot if available. **You do not have to pay the parking fees**. Please make certain your handicapped tag is clearly displayed so the parking enforcement personnel do not issue you a citation.

OCBP License Plates

Listed below are the guidelines for receiving these special logo plates:

Your vehicle must be registered in Maryland. Pick up MVA form VR-124 from Captain Arbin.

Fill out form completely.

Attach a check made payable to the Ocean City Beach Patrol Surf Rescue Association

(OCBPSRA) for \$50.00. This is a one-time fee and will not be charged again.

If you are requesting a specific number, make sure it is still available.

Return form to Beach Patrol Headquarters. Do not send or take to MVA—the form needs an authorizing signature to

Once the VR-124 form and check have been received, it takes 4-6 weeks to receive the tags. They will be mailed to the address on your registration.

In the future, you will receive the regular tag renewal application directly from the MVA every 2 years.

OCBP Question-of-the-Week for The Worcester County Times

Last Week's Question: What are you doing with those flags? The surf rescue technician's (lifeguard's) flags serve two purposes. First, they are used in one of the three communications methods that the beach patrol uses to communicate among themselves. This form of communications is called semaphore. Semaphore is a type of communication by which a person signals with two hand flags, moving his arms through various positions to represent letters, numerals and special signs. Semaphore is also used by the Scouts, Navy and Coast Guard to communicate over long distances (as long as you can see the other person). Although this method has been around for a long time, a major benefit to the beach patrol is that in an emergency or when a lifeguard is in the water, they do not need any electronics or technology to immediately update and communicate with each other. The majority of messages being sent between lifeguards are communications about lost and found individuals and potential dangers.

Example:LB N ADAM A ATE RED

Lost Boy Name Adam Age eight bathing suit color red

Above is an example of one type of a message that SRTs send between adjoining stands. This information is also transmitted by radio to the beach patrol dispatch center for broadcast to other agencies and departments throughout Ocean City.

Note: We respond to approximately 2,000 cases of lost and found individuals in a typical season with a 100 percent return rate. To learn more about semaphore, visit the beach patrol websit, www.ococean.com/ocbp; click on the semaphore alphabet link under employee links.

The second use of the flags is to direct beach patrons out of harm's way. Although we do not expect any of our beach patrons to understand this signaling system, we also use the flags to indicate and point to our visitors. The SRT may point at you and direct you to move in a particular direction or to stop an activity such as ball playing in the water. This gentle signaling may be all it takes to warn and move you out of potential danger, such as rip currents, dangerous shorebreak or even marine life such as we saw with last year's whale sightings. So remember, when an SRT whistles and points, locate them and make sure they are not trying to tell you something.

Interesting note: The popular peace sign is really the combination of two semaphore letters N and D and stands for Nuclear Disarmament. The other two communication methods used by the beach patrol are a whistle system and two-way radios.

Hence our slogan, "Keep your feet in the sand until the lifeguards in the stand". Heeding this simple warning could save a life, YOURS!

This Week's Question: I notice the lifequards make everybody get out of the ocean before they leave, but people go back in. Why is that? The beach patrol has known of, or been involved with dozens of drownings and near drownings that have occurred outside our 10 a.m. to 5:30 p.m. "duty" hours (over 97 percent of all water-related deaths in Ocean City in the past 80 years have occurred while the Ocean City Beach Patrol is off duty). The single, strongest message that we try to impress on people is that they should stay out of the ocean when lifeguards are not on duty. Many times we have been involved in cases where, if this simple rule had been followed, lives and families would not have been impacted by such a preventable tragedy. Clearing the water at the end of our shift may seem routine, but we never take the goal of this policy lightly. Before we started the policy of clearing the water of swimmers at 5:25 p.m., it was very possible that a swimmer could have entered the water while guards were on duty, only to turn around and find the stands empty and pulled back for the night. In most cases this would not be a problem. However, if the swimmer were to become caught in a rip current, the situation could quickly take a tragic turn, despite their intentions to swim only under the watchful eyes of the Beach Patrol. In contrast, by pulling everyone out of the ocean before we leave the beach, we know that those who enter the water during unquarded hours are taking that risk knowingly. The risk is great, although many of the 2,000 – 4,000 people who we rescue during guarding hours tell us that they never intended to go out that "far", they do not make the connection to the fact that rip currents (the 3rd leading cause of weather related deaths nationally) will actually pull a person from waist deep water to water that is over their head quickly and without warning. These same currents that are the cause of 95% of all rescues we make during the day are also present before and after we are on our stands. The only difference is that when a person finds themselves in trouble before 10:00 AM or after 5:30 PM. there is no one to save their life and unfortunately it all too often has ended in tragedy. We continue our efforts to educate the public, warning them of the dangers of swimming on unguarded beaches, and that we make sure people leave the ocean before we pull our lifeguard stands back and cross over the dune for the night.

Our slogan, "Keep your feet in the sand until the lifeguard's in the stand." Heeding this simple warning could save a life, yours!

Dogs on the Beach

Read below for important answers to common questions regarding dogs in and around the Ocean City beach area.

Q: Are dogs allowed on the beach or boardwalk?

Animals are not permitted on the beaches or boardwalk of Ocean City at any time during the period from May 1 through September 30 of each year. All dogs must be on a leash at all times, including when on the beaches during the offseason.

Town of Ocean City Code, Sec 106-94 (6).

Town of Ocean City Code, Sec 6-34 (19), (24), (25)

Q: What about service animals?

Service animals are any animal that are individually trained to do work for people with disabilities. Service animals must be allowed to accompany people with disabilities in all areas where the public is normally allowed to go. Service animals must be under control. There is no certification, or requirement that service animals be marked or carry documentation.

So, when you are asking a beach patron to remove an animal from the beach, if they tell you it is a service animal, it is permitted to remain on the beach. You cannot ask for documentation, nor should you attempt to question the person. Advise your Crew Chief and Area Supervisor of the location of service animal and a description of the animal so that the person is not constantly questioned about the animal. If a service animal is not under control, or if there is a problem with the service animal, contact the area supervisor.

Q: Is there a dog park in Ocean City?
Yes, Little Salisbury Park located at 94th St. has a dog park with separate small dog and large dog areas. See http://oceancitymd.gov/Recreation_and_Parks/dogplayground.html for more information. Passes can be obtained at the Parks and Recreations Department front desk at 200 125th St. 410-289-0125

Q: So where can I take my dog on the beach?

Assateaque Island Nation Seashore, in limited areas. Dogs must be leashed. Note, the state park does not allow pets. For specific areas, contact them at 410-641-1443. See http://www.nps.gov/asis, look for "pet regulations" in the "Plan your visit" section.

Fenwick Island, DE State Park allows dog at the Surf Fishing Beaches only. Dogs must be leashed. This beach is between Bethany Beach and Fenwick Island. Contact them at 302-227-2800.

Q: Can I just leave my dog in the car?

No, temperatures in the car rapidly rise and will endanger the welfare of the animal, even if a window is cracked open. In Maryland, it is illegal to leave a cat or dog in a standing or parked motor vehicle in a manner that endangers the health or safety of the cat or dog. If discovered, police may use reasonable force to remove from a motor vehicle a cat or dog left in the vehicle in violation.

MD Code, Transportation, § 21-1004.1

Q: So, I brought my dog into Ocean City, and now I need to kennel my dog. Where can I do so?

Summer has officially arrived and for many people that means pulling the floaties out of storage and hitting the beach. Well, before you barrel onto the freeway to hit the surf and sand, it's worth doing some research about just what is waiting for you in that water – and we're not talking sharks.

According to the Natural Resources Defense Council's 23rd annual beach water quality report, released Wednesday, many of America's beaches have some serious water pollution issues. But never fear, the report also includes beaches with 5-star "superstar" ratings, so you can skip the bacteria soup and head to a better beach.

"Sewage and contaminated runoff in the water can spoil a family vacation real fast, turning a day of lounging at the beach into a day at the doctor's office with a sick child," said NRDC senior attorney Jon Devine.

The report, "Testing the Waters: A Guide to Water Quality at Vacation Beaches," is a collection of the latest beach water quality data from the U.S. Environmental Protection Agency from more than 3,000 testing locations nationwide. Click here for the full report and zip-code searchable map.

This report focuses on just one but critical element of beach water quality: bacterial contamination --so pollution pretty much created by human and animal waste. The authors note that there are all types of pollution that destroy beaches and cause serious illness, and a definitive list on the "cleanest" and "dirtiest" beaches based on all these types of pollutants would be "almost impossible" to put together.

So with that in mind, here's a list of some of America's cleanest and dirtiest beaches.

Cleanest - Alabama: Gulf Shores Public Beach in Baldwin County

Cleanest - Maryland: Ocean City at Beach 6 in Worcester County

After briefly speaking with you on the telephone you requested I send a letter on

behalf of my experience.

I have been visiting the town of Ocean City since I was around 10 yrs. old or perhaps longer some 40 plus years... just put it that way. While visiting Ocean City this past week June 20th-June 23rd I stayed at the Dunes Manor Hotel located on 28th-29th Street. The weather was beautiful. however the water was dangerous with rip currents, you could see them extremely well from a higher point such as our balcony.

One day in-particular, I believe that was on Saturday June 22nd, the Lifeguard was giving his Informational speech to the beachgoers about the conditions of the water, while doing so two men were in the water (at the edge of a sandbar) one with crutches and the other one helping, in a blink of an eye a wave knocked them both down and within seconds the Lifeguard was there bringing him to safety. The man on crutches had a partial amputated leg. It was just a remarkable job the Lifeguard performed, and it happened to be while all the beach goers were looking on. The rest of the afternoon went on as normal. Days prior to I observed this Lifeguard rescuing an average of 4 plus daily from the rip currents. He was friendly to all, young children showing him their crabs, the seniors asking questions, concerned parents, etc. He gave speeches more than once that's for sure. Also observed that while having his lunch break he continued to zone in on the waters. Astonishing!!

The Lifeguard showed leadership and commitment to his job. He will be an inspiration to others. The training, hiring, and overall supervision of the beaches is absolutely wonderful.

I know your wondering by now who is this young man? His name is PAUL, and I am pleased to say I had the honor to shake this young mans hand. He is a Lifesaver!!!!

Ocean City should become or is one of the safest Beach Resort Towns located on the East Coast. I have witnessed this first hand from NJ to FL.
