- **Three current photographs of your product and one current photo of your display**
- **A list of the last 3 shows you participated in as a reference**

ARTS & CRAFTS APPLICANTS: Also provide a written summary of your arts and crafts process as well as an artist statement.

This is a juried show. Selection is based on quality and skill of workmanship, unique ideas and an attractive booth display. All information must be completed for consideration. This is an application only and in no way reserves a booth space. APPLICATION DEADLINE: MARCH 1, 2014 or until show is full. We do build a waitlist for Springfest.

Arts & Crafts Artisan: A crafter who offers for sale items which are no less than 90% handmade by him or her. These items must be crafted by the person who submits this application. Absolutely NO commercial items are permitted in an arts and craft space.

Commercial Vendor: A vendor who has items for resale that are mass-produced or made by someone else and/or a vendor with any other commercial endeavor or interest (fabricated by someone other than the vendor). Commercial vendors must provide their own tent.

Food Vendor: A food vendor is one who prepares raw food products on site or who prepares food products off site and samples on site. Both types of food vendors are subject to State of Maryland and Worcester County Health codes requirements. **Food vendors must work out of a booth, not out of a trailer.**
