

## BUSINESS LICENSE FEES

The license fees are paid annually for conducting businesses and engaging in occupations and activities listed below. However, no single license for a single designated place shall exceed \$2,861 per annum. If a license is not obtained, it is subject to a late charge of ten percent after 15 days and two percent each month every 30 days thereafter:
