NOTICE TO ALL BIDDERS AND PLANHOLDERS

1.0 – QUESTIONS AND ANSWERS

The following questions and answers are provided as a matter of information to clarify issues raised about the Bid Documents.

Item	Questions and Answers
1.0	<p>Contractual: Did you submit your "Letter of Intent," within the required timeframe to mitigate a potential renewal period of your current contract with Ricoh (<i>typically, a written notice of intent is required between 90-120 days of contractual commencement to avoid the contractual renewal period</i>)? (Expiration: April 2016).</p> <p>We have not submitted a letter of intent yet and will not until we, the Town, are ready to award.</p> <p>If not:</p> <p>Are you currently in a renewal period? If so, until when? Yes, the lease will renew for 60 consecutive days after the expiration of the agreement until we give the current vendor at least 60 days' notice of our intent to dissolve the agreement.</p> <p>Were you instructed (prior to renewal) on terms & conditions? No</p> <p>What is your remaining financial obligation on current leased equipment?</p> <p>Total Buyout? There is no buyout</p> <p>Total Buyout (less all remaining M&S obligations): This is not applicable</p> <p>Buyout-to-Return: The cost to return the equipment will include freight and insurance pre-paid by successful vendor and will be returned in good repair, condition and working order, ordinary wear and tear expected, in a manner and to a location designated by Ricoh.</p>
