- A. Mayor Meehan called the meeting to order at 10:10 a.m. at the Roland E. Powell Convention Center, Room 215. The Mayor welcomed attendees.
 - a. The Worcester County Commissioners took the lead on this project but was recently voted down by the Commissioners. It is now an Ocean City project but the door is still open if the County wishes to be involved. The Mayor and City Council have identified this project as a number one priority in the Strategic Plan and Capital Improvement Plan. This task force is similar to the Blue Ribbon Committee for the Roland E. Powell Convention Center project. Since then, the Town has expanded the convention center three times. The group will discuss five issues today. 1. Determine the scope of the project. Will it be indoor, outdoor or both? 2. What sports do we want to accommodate? 3. Size of the site? Will it be built in phases? 4. Course of action for pursuing legislation. 5. Location of properties discussed in closed session.
- B. Mayor Meehan asked members to introduce themselves.
- C. Tom Perlozzo provided history and background on the project when Worcester County was spearheading efforts.
 - a. Discussion and history on why the County chose the initial property at Rt. 50 and Stephen Decatur High School.

 - c. Size of Property: Big enough property to accommodate what is being proposed with the ability for future expansions.
 - d. Determine best course of action for following up with the legislature: Work with the Maryland Stadium Authority through the legislative process with the Maryland General Assembly to:
 - i. In 2023, obtain funding for design.
 - ii. In 2024, obtain funding for the project to move forward with construction.
