

## **Ocean City Police Department Trespass Enforcement Authorization Program**

Dear Property Owner/Manager,

The Ocean City Police Department is reaching out to all property owners, residents, and businesses in an attempt to further strengthen existing partnerships through the Trespass Enforcement Authorization Program (T.E.A.P.).

Our goal is to get EVERY property that is not open 24/7/365 to join this program so that the Ocean City Police Department may effectively and efficiently address peace and good order issues on private property.

Property owners/managers who sign up for the program pre-authorize the Ocean City Police Department to enforce, at their discretion, trespassing laws on participating properties. This is especially important during night time hours when contacting owners and managers is inherently problematic and inconvenient to all.

The Ocean City Police Department wants everyone to come and enjoy Ocean City while respecting the rights of others. OCPD's goal in this program is to gain voluntary compliance first before resorting to criminal citation or arrest.

In order to quickly facilitate enrollment in the program, the Ocean City Police Department is waiving the cost of the Trespass Enforcement Authorization Program signs. Interested property owners/managers may download the T.E.A.P. application (Right of Entry letter), fill it out, notarize it, and either email a copy of the notarized letter or mail it to the following address:

Notarized T.E.A.P. agreements may be emailed to oppdrecords@oceancitymd.gov.

Once the application is received, arrangements will be made for a site survey to be conducted to determine eligibility and number of signs required. Once the property is approved, the property owner/manager will receive a letter indicating the properties approval. T.E.A.P. signs may be picked up at the Ocean City Police Department, Records Section and installed by the owner/property manager.
